Peb suavdlawg tseem muaj txujsa nyob yog Vaahtswv txuj kev hhub. Ua ntej nuav, nyuas yaus thov qhuas hab ua Vaahtswv tsaug rua Nwg txuj moovhluab hab kev tiv thaiv peb suavdlawg; rua qhov lub xyoo nuav yog ib lub xyoos txawv dlua txhua xyoo dlhau lug. Tsi muaj leejetwg paub hastas peb lub neej yuav hloov ntaw yaam, tsuas yog Vaahtswv txhajle paub xwb.

Xyoo nuav yog ib lub tsaam thawj nyuaj rua peb suavdlawg xwsle: muaj suavtawg kub nyaab ob peb lub xeev (states), muaj kev sis tawm tsaam nruab nraab ntawm cov tuabneeg nqaj taww sis txawv hab tug Kaabmob-19 (Covid-19). Tseem muaj ntaw yaam xwmtxheej, kev txhawj ntshai, kev mob nkeeg hab kev pluj tuag, coob tug poob dlejnum, ua rua tsev tuabneeg hab cov txheebze nrug rua cov phoojywg kev sis ntsib tu lawvle peb tub paub lawm. Kuv muab Nau-es lub neej txhawb peb zug rua lub sijhawm nuav. *Tug Tswv kaw lub qhov rooj nkoy (Chivkeeb 7:16b)* yog Nwg tiv thaiv Nau-es tsev tuabneeg. *Nau-es hab nwg tsev tuabneeg nyob huv lub nkoy, naag lug tau 40 nub 40 mo, hab dlej fuam sab zuij zug ua rua lub nkoy nqaa hlo ntaab yeeg lawm (Chivkeeb 7:17).* *Tau 150 nub dlej yeej tsi nqeg le (Chivkeeb 7:24) hab dlej pib nqeg zuij zug tau 150 nub (Chivkeeb 8:3).* Muab xaam lug Nau-es puab nyob huv lub nkoy yuav laug tau ib xyoos los yog. Qhov nuav qha rua peb hastas lub sijhawm kws muaj ntaw yaam xwmtxheej, tshwjxeeb yog tug Kaabmob-19, pev ib yaam le naag lug 40 nub 40 mo ntaag, tabsis Vaahtswv yog tug tiv thaiv peb. Txawm yog tug Kaabmob-19 fuam luu zuij zug ib yaam le cov dlej, los tom qaab 150 nub yuav dlhau moog ib yaam le dlej pib nqeg. Thaus peb ua neej taug kev rua huv lub nplajteb kws tsi muaj kev ruaj khov; tej kev nyuaj nyob nrug peb, hab peb yeej tsiv tsi dlhau tej kev nyuaj lossis tej xwmtxheej ntawd. Tabsis kuas peb ncu hastas **Vaahtswv yog peb lub chaw nkaum hab yog peb tug dlaag tug zug**, thus muaj kev txomnyem **Nwg npaaj txhij paab** peb txhua lub sijhawm. Peb tsi xob ntshai, rua qhov **Vaahtswv yog tug muaj fwjchim** (Ntawv Nkauj 46).

Lug ntawm Vaahtswv lub fwjchim, cov tsaavxwm KHN, cov thawjcoj txhua pawg namtsev hab ib tsoom vivncaug suavdlawg tuav peb txuj kev ntseeg; peb txhaj le nyob nyaab xeeb hab muaj pee vxwm tiv taug tej kev nyuaj ntawd lawvle **Yakaunpaus 1:2-4** hastas, “*Cov kwvtij, thus mej raug ntaw yaam kev nyuajsab, cale suav hastas tej ntawd yog koobmoov zoo kawg. Rua qhov mej paub tas thus mej txuj kev ntseeg kovyeej tej kev simsab, yuav ua rua mej muaj pee vxwm tiv taug. Mej yuavtsum ua sabntev moog le tsi xob tso tseg, mej txhajle ua tau tuabneeg zoo kawg nkaus, tsi muaj ib yaam kws yuav tu ncua le.*” Yog le ntawd, peb yuavtsum zoo sab lug ntawm tej kev nyuaj kws peb raug, muaj txuj kev ntseeg ruaj lug ntawm tej kev simsab hab ua tau sabntev tiv. Ca peb ruaj sab rua Vaahtswv, rua qhov Nwg paub txhua yaam hab Nwg yog tug kws tswj txhua yaam.

Xyoo nuav KHN npaaj tau ntawm yaam dlejnum yuav ua, npaaj muaj rooj txhawbsab hab roo cobqha, tabsis muaj tug Kaabmob-19 txhajle muab cov dlejnum nuav ncua taag lawm. Txawm yog muab tej nuav ncua lawm los, Vaajtsvv pub rua cov tuabneeg txawj ntse rhawv muaj vaag-xub hab tej ci-xub (internet and technology) rua peb siv ua Vaajtsvv dlejnum, saablaaj hab sis txoos uake huv vaag-xub (Zoom). Peb txhaj le muaj ntawm txuj kev ua Nwg dlejnum tsi tso tseg. Thov qhuas Vaajtsvv lub fwjchim.

NTXIV yog lub Ntsab Lug rua xyoo 2019. Nyob rua ntawm Yaxayas 61:3b hastas, “Puab yuav zoo ib yaam le tsob ntoo kws tug Tswv cog tseg. Puab yuav ua ncaaj ua nceeg mas suavdlawg yuav qhuas Vaajtsvv vim tej dlejnum zoo kws Nwg tau ua lawm.”



TSO DLIM yog lub Ntsab Lug rua xyoo 2020. Nyob rua ntawm Yauhaas 8:36 hastas, “*Yog leej Tub tso mej dlim, ces mej yeej yuav dlim tag-tag le.*”



Ua tsaug rua Thawj Tsaavxwm HKM kws yog Kx. Tswv Txos Thoj nrug rua N. Kx.
