ARTICLE IV – RELATIONSHIP

Great Commission Women is an auxiliary ministry of the district and is amenable to the District Superintendent. It is part of Great Commission Women National ministries and is related to the Area (where applicable), and Local organizations. It shall include those who are participants in Great Commission Women in the district churches of The Christian and Missionary Alliance.

ARTICLE V - STRUCTURE

Section 1. Teams/Committees

- a. **District Leadership Team.** A Leadership team shall meet for the purpose of considering items of business and programs pertinent to the development of Great Commission Women District Ministries. This team shall be elected as per Article V, Section 2b or appointed by the District Superintendent and DEXCOM as per Article V, Section 2c.

(This team shall be elected per the Annual Conference of The Hmong District 2009, follow Section 2b.)

- b. **Ex-Officio.** The District Superintendent, the wife of the District Superintendent and if applicable, the wives of other district officers recommended by the District Superintendent, as well as any current member of the National Executive Team of Great Commission Women residing in the district, shall be ex-officio members of the District Leadership Team. The District Director shall serve as a member of all standing and special committees.

PHAAJ IV – KEV FEEMXYUAM

Great Commission Women (Koomhum Namtsev) yog ib phaab dlejnum ntawm nwg lub koomhum hab nyob huv qaab kev tswifwm ntawm tug Thawj Tsaavxwm. Cov tswvcuab yog txhua tug namtsev kws zwm rua tej pawgntseeg huv lub koomhum ntawm Cov Ntseeg Yexus hab Kev Koomteg Qha Txujmoo Zoo.

- b. **Cov Tsaavxwm Tshwjxeeb.** Tug Thawj Tsaavxwm, nam Thawj Tsaavxwm hab yog tas muaj, tug teevntawv lossis tug canyaj ntawm hauvpaug koomhum tug quaspuj kws Thawj Tsaavxwm pumzoo, nrug rua tug tsaavxwm Koomhum Namtsev Qebsab kws nyob huv yug lub koomhum, yog cov tsaavxwm tshwjxeeb ntawm paab Thawjcoj Koomhum Namtsev. c. Nominating Committee. The Nominating Committee shall be appointed by the District Leadership Team. It shall be comprised of a minimum of three members – one member from the District Leadership Team and two or more members from the district membership-at-large. The Nominating Committee shall place one name in nomination for each office to be filled except the office of the Director. In those districts in which the Director is chosen by election of the District Conference, the Nominating Committee may recommend a candidate for Director to the District Committee on Nominations at the District Conference.

The Nominating Committee shall serve during the Alliance Women Ministries' Annual Conference to prepare what needs to be in place for elections. Their service is on a one time to time basis.

d. Other Committees. The District Executive Team may appoint other committee(s) as deemed necessary. The number of people appointed to the committees will be determined by the District Executive Team as is needed to carry out the tasks. This committee(s) will carry out the tasks given by the District Executive Team.

The term of service for the appointed committee(s) will be determined by the District Executive Team, or on a one time to time basis.

c. **Appointments.** If the district chooses to appoint officers, the appointments shall be as follows:

- (1) The Great Commission Women Director shall be appointed by the District Superintendent and approved by the District Executive Committee. The Director shall be a person of good Christian character and a member in good standing of a Christian and Missionary Alliance church.
- (2) All other positions may be appointed by the Great Commission Women District Director with the approval of the District Superintendent and her present Leadership Team. The officers shall be persons of good Christian character and members in good standing of a Christian and Missionary Alliance church.

Section 3. Officers

a. **Director.** The Director shall be responsible for carrying out the objectives of the organization and shall be amendable to the District Superintendent. She shall preside at all Great Commission Women District meetings.

The elected or appointed term of office shall be four years. The Director is eligible for not more than two consecutive terms in this office.

(The term of office for the Director – see Hmong District's Bylaws Article III, D8, pages 11-12)

c. **Kev Taw Npe.** Yog hastas lub koomhum pumzoo taw npe cov tsaavxwm, yuav tau taug txuj kaabke taw npe lawvle nraag qaab nuav:

- (2) Dlua le lwm lub meejomom, Thawj Namtsev muaj cai taw puab cov npe nrug rua kev pumzoo ntawm Thawj Tsaavxwm hab paab Tsaavxwm Koomhum Namtsev xyoo ntawd. Txhua tug tsaavxwm yuavtsum yog tug ntseeg Yexus kws muaj tug xeebceem zoo hab yog ib tug tswvcuab zoo ntawm ib pawgntseeg kws zwm rua huv Cov Ntseeg Yexus hab Kev Koomteg Qha Txujmoo Zoo.

Feem 3. Cov Tsaavxwm

a. **Thawj Namtsev.** Tug Thawj Namtsev yog tug lug leg cov homphaj dlejnum ntawm lub koomhum kuas tav hab nwg nyob huv qaab kev tswjfwm ntawm tug Thawj Tsaavxwm. Nwg yog tug tswj txhua lub rooj saablaaj ntawm Koomhum Namtsev.

Tug kws raug xaiv lossis raug taw tau lug tuav lub meejomom nuav noobnyoog ua dlejnum yog plaub (4) lub xyoops. Nwg muaj cai raug xaiv ua tug Thawj Namtsev tsi pub tshaaj ob (2) zag sis law.

The Director shall submit an annual report to National Great Commision Women. She shall attend the National Leadership Team meeting (General Council). She shall work alongside the District Executive Team to plan for the Annual Conference. She shall submit and present an annual report to Alliance Women Ministries' Annual Conference and the Annual Conference of The Hmong District.

- b. **Assistant Director (if applicable).** The Assistant Director shall preside at all meetings in the absence of the Director and shall fulfill specific responsibilities as delegated by the Director. In the event of the resignation or death of the Director, the Assistant Director shall fill the vacancy until the regular election or appointment of the Director.

The elected or appoint term of office shall be four years. The Assistant Director is eligible for not more than two consecutive terms in this office.

(The term of office for the Assistant Director – see Hmong District's Bylaws Article III, D8, page 12)

The Assistant Director shall be elected the year following the election of the Director.

- c. **Secretary.** The Secretary shall keep the minutes of all Great Commission Women District business meetings, the District Leadership Team, and District Executive Team and shall conduct the correspondence as directed by the District Executive Team.

- d. **Treasurer.** The Treasurer shall keep a complete and accurate record of all receipts and disbursements and shall disburse funds as authorized by the District Executive Team.

If elected or appointed, the term of office shall be four years. The Treasurer is eligible for not more than two consecutive terms in this office.

The Treasurer shall be elected one year after the Secretary.

(The term of office for the Treasurer – see Hmong District’s Bylaws Article III, D8, page 12)

- e. **Member-at-Large.** The member-at-large is a member of the District Executive Team and shall serve as directed by the District Executive Team.

If elected or appointed term of office shall be two years. The Member-at-Large is eligible for not more than three consecutive terms in this office.

- f. **Media.** The Media is a member of the District Executive Team. She shall be responsible for the managing Alliance Women Ministries’ website, all matters of communication, technology, and all other duties related to this ministry.

In the event of resignation or death of one of these officers, the District Executive Team shall appoint a member to fulfill the position until the position is filled by election or appointment, except for the position of the Director.

Section 4. Records of Officers. The official records of all officers and departments of Great Commission Women District ministries are the property of Great Commission Women District ministries. All financial records shall be audited annually or at any time on order of the District Superintendent and/or the District Executive Committee. In the event of the death or resignation of the incumbent, or upon the election of her successor, the current records necessary for fulfilling the obligations of the office shall be passed on to the newly elected officer.

Section 5. Other Committees

a. **Auditor.** *The Auditor is an impartial member between the women and the District Executive Team. The Auditor shall audit the financial records of the Alliance Women Ministries of The Hmong District twice a year and shall submit a report of findings after each audit. The Auditor shall be elected or appointed at the Alliance Women Ministries' Annual Conference.*

- b. **Trustees.** The District Executive Team shall appoint a committee to oversee all physical properties and assets of the Alliance Women Ministries of The Hmong District. The committee members shall live near where the physical properties are being stored.

Their term of office shall be two years, begin and end with the Director. There shall be no limit on the terms of office served.

- c. **Prayer Team.** The District Executive Team shall appoint a Prayer Team to work alongside the Member-at-Large to support the ministry of prayer. The number of appointees necessary for the Prayer Team shall be decided by the District Executive Team. The Prayer Team shall serve or pray for all items, ministries, projects, and events as provided by the District Executive Team or the prayer coordinator.

Their term of office is on a year to year basis.

ARTICLE VI – MEETINGS

Section 1. Great Commission Women District Meetings.

Events may be held by Great Commission Women District ministries to accomplish its objectives. Such meetings shall be the responsibility of the District Leadership Team, and the program shall be approved by the District Superintendent. Any business pertinent to the organization may be conducted on these occasions.

Section 2. Annual Meeting.

The Annual Meeting of Great Commission Women District ministries shall convene at a district event or district conference to consider essential matters of business.

a. **Members.** Those able to participate, motion and vote in the business of the Annual Conference of Alliance Women Ministries are as follows:

1. Members of the the District Executive Team.
2. Delegates from the local Alliance Women Ministries.

Delegates: Each local Alliance Women Minintries may send up to three delegates to the Annual Conference. Local Alliance Women Minintries groups having 50 to 100 members, may add one more delegate (a total of 4 delegates). One more delegate may be added for every 100 members thereafter (total of 5 delegates).

(Annual Conference 1992)

3. All pastors' wives, whether they are delegates or correspondences.

Section 3. District Leadership Team or District Executive

Team Meetings. The District Leadership Team or District Executive Team shall meet as needed at the request of the Director or the District Superintendent.

ARTICLE VII – FINANCE

Section 1. Reimbursement of Expenses. The work of the District Leadership Team shall be considered a service to Christ and the Church. Expenses related to this ministry shall be reimbursed.

Reimbursements of expenses to the District Executive Team shall be conducted according to the Operating Procedures of the Alliance Women Ministries.

Section 2. Ministry Fund. An annual budget proposal shall be prepared, presented and adopted by the GCW District Leadership Team in consultation with the district Superintendent to fund GCW District initiatives and planning. Subsequently, an annual audit shall be completed to verify the use of funds.

Revenues for Alliance Women Ministries:

a. ***Tithe.*** All local Alliance Women Ministries groups affiliated with Alliance Women Ministries shall send in one-tenth (10%) of their monthly income from the love offering and donations.

Section 3. Projects. Great Commission Women District ministries are expected to support the projects established by Great Commission Women National ministries. All other district-wide appeals for funds shall be approved by the District Superintendent.

ARTICLE VIII - AMENDMENTS

These policies may be amended by the Vice President for Church Ministries with the approval of the Board of Directors of The Christian and Missionary Alliance.

The Policies of Alliance Women Ministries may be amended only if it is approved by a two-thirds vote at the Annual Conference, however before any item can be amended it must have prior approval by the DEXCOM of The Hmong District.

ARTICLE IX – OPERATING PROCEDURES

Operating procedures not in conflict with these policies may be adopted at any regular meeting of Great Commission Women District ministries by a two-thirds vote of the members present. Proposed Operating Procedures shall be submitted to the Executive Committee of the District for approval.

ARTICLE X – GREAT COMMISSION WOMEN AREA MINISTRIES

Any district using the Area structure shall use the District Policies with the following adaptation:

- a. Great Commission Women Area ministries shall have an Area Leadership Team or representative as determined in Article V, Section 2, or as appointed by the District Leadership Team. This Team shall meet for the purpose of considering items of business and programs pertinent to the development of Great Commission Women ministries.
